In view of the above, you are requested to submit the above documents immediately for further processing of the case.

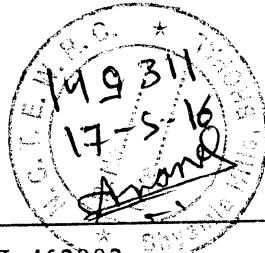
