4. If the institution misguides the Visiting Team by taking it to some other location/building than the one for which documents were submitted with the application, action against the authorized representative of the Society/Trust/Institution will be taken by the WRC, under the relevant laws of the land including civil and criminal proceedings, whichever is applicable.

5. You are requested to provide the Visiting Team same land documents including certified copy of land deed, notarized copy of CLU, notarized non encumbrance certificate from the competent authority, approved building plan, building completion certificate which were submitted with the application, for verification/ identification of the land, building etc.

6. You are also requested to show the Visiting Team the other documents as asked for by them for verification of the same, at the spot.

7. Arrangements for videography shall be made by the Society/Trust/Institution at their own expenditure at the time of inspection. The institution shall arrange for the inspection to be videographed in a manner that all important infrastructural and instructional facilities are videographed alongwith interaction with the management and the faculty, if available at the time of such visit. The videography should clearly establish the
