AND WHEREAS, the institution, Pitambara College of Education, Plot no.: 955/1, 955/2, 956, 957, 958, 962 etc, Street/Road: Bhandar Road, Vill.: Datia, P.O.: Datia, Teh./Tal.: Datia, Town/City: Datia, Dist.: Datia - 475661 Madhya Pradesh (WRCAPP3225) has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 245th meeting held on March 1-3, 2016 is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.A.B.Ed. integrated programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

The recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.
