Whereas, the WRC (NCTE) has granted recognition to the **Pushpanjali College Of Education, Vasai, Dist-Thane Maharashtra** for conducting B.Ed. course of one year duration with an annual intake of 100 students vide order No. WRC/5-6/14/99/2195-2197 dt. 08.04.1999.

2. And whereas, after the promulgation of NCTE Regulations, 2014 a letter for submission of an affidavit, regarding acceptance and compliance of NCTE Regulations, 2014, was issued to the institution on 09.01.2015. The institution has submitted an affidavit dt. 09.01.2015 vide letter dt. 03.11.2015.

3. And whereas, previous recognition order dt. 08.04.1999 and a revised recognition order no. WRC/APW0553/113090/2015/147661 dt. 31.5.2015 has been issued to the institution for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each).

4. And whereas, the institution vide its letters dt. 15.07.2015 & 21.05.2015 has submitted and requested the WRC (NCTE) to reduce the existing annual intake of 100 seats (2 units) to 50 seats (1 unit).

5. And whereas, the matter was placed in 259<sup>th</sup> meeting of WRC held on September 21-23, 2016 and the Committee decided that "...Institutions which have requested for reducing intake may be permitted."

6. Now, therefore, **existing annual intake of 100 students (two units of 50 students each) for conducting B.Ed. course of two years duration is hereby reduced to an annual intake of 50 students (one unit of 50 students each) from the academic session 2017-2018.**

7. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

8. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

9. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- Sanctioned programmers along with annual intake in the institution;
- Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- Name of faculty members who left or joined during the last, quarter;
- Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- Fee charged from students;
- Available infrastructural facilities

- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

10. Revised Recognition order no. WRC/APW0553/113090/2015/147661 dt. 31.5.2015 be treated as cancelled from the date of issue of this order.
