ORDER

WHEREAS, in terms of section 15(3)(a) of the NCTE Act 1993, WRC granted recognition to GANDHI NATIONAL COLLEGE, D/1, DANISH NAGAR, HOSHANGABAD ROAD, BHOPAL, MADHYA PRADESH for D.Ed. course vide order dated 22.12.2008 for an annual intake of 50 seats.

AND WHEREAS, the permission for change of name was granted by WRC vide order No.WRC/5-6/APW00635/223177/161/2012/90542 dated 21.05.2012.

AND WHEREAS, the institution now requested for change of name of the institution from GANDHI NATIONAL COLLEGE, BHOPAL to **GANDHI P.R. COLLEGE, BHOPAL** for conducting D.ED. course.

AND WHEREAS, the matter was placed in 235th Meeting of WRC held on November 23-24, 2015 and the Committee decided that "...The institution was asked to remove the word 'National' from the name of the college as per the instructions given by various Apex bodies. Accordingly, the institution has requested for a change in the name of the college from 'Gandhi National College' to 'Gandhi P.R. College'. **The Committee decided to permit the change of name of the institution.**"

NOW THEREFORE, the permission is hereby granted for change of name of the institution from GANDHI NATIONAL COLLEGE, BHOPAL to **GANDHI P.R. COLLEGE, BHOPAL** with immediate effect.
