**ORDER**

AND WHEREAS, the institution now requested for change of name of the institution from GANDHI NATIONAL COLLEGE, BHOPAL to **GANDHI P.R. COLLEGE, BHOPAL** for conducting D.ED. course.

AND WHEREAS, the matter was placed in 235<sup>th</sup> Meeting of WRC held on November 23-24, 2015 and the Committee decided that "...The institution was asked to remove the word 'National' from the name of the college as per the instructions given by various Apex bodies. Accordingly, the institution has requested for a change in the name of the college from 'Gandhi National College' to 'Gandhi P.R. College'. **The Committee decided to permit the change of name of the institution.**"

NOW THEREFORE, the permission is hereby granted for change of name of the institution from GANDHI NATIONAL COLLEGE, BHOPAL to **GANDHI P.R. COLLEGE, BHOPAL** with immediate effect.
