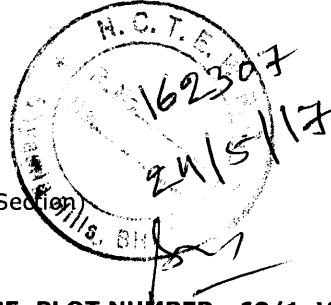
ORDER

WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to BHARAT COLLEGE OF EDUCATION, PLOT NUMBER : 68/1, VILLAGE : KALA PAHAD, POST OFFICE : DATIA, TEHSIL/TALUKA : DATIA, TOWN/CITY : DATIA, DISTRICT : DATIA 475661, MADHYA PRADESH for D.El.Ed. course vide order dated 26.02.2014 for an annual intake of 50 students.

AND WHEREAS, the institution applied for change of name from BHARAT COLLEGE OF EDUCATION to BHARAT COLLEGE.

AND WHEREAS, the matter was placed before WRC in its 272nd Meeting held on April 6-8, 2017 and the Committee decided that "...the institution had requested for a change of name of the college from "BHARAT COLLEGE OF EDUCATION, Datia" to "BHARAT COLLEGE, Datia". **Since, the institution has paid the required fee, change of name is permitted.** The change of name should be noted in the files of B.Ed. and D.El.Ed. courses."
