As you may be aware, that the NCTE has been established by an Act of Parliament (Act No. 73 of 1993) with a view to achieve planned and coordinated development of teacher education system throughout the country, the regulation and proper maintenance of norms and standards in the teacher education system and for matters connected therewith. 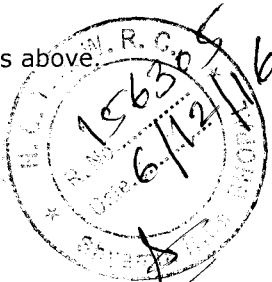
"...Show Cause Notice was issued to the institution on 18/04/2016. The institution replied on 14/04/2016 and on 26/09/2016. The committee expressed doubts about the genuineness of some of the documents submitted by the institution either from persons who have signed the documents or because the documents are not in proper format and other such reasons. The Committee therefore, decided to ask the RD to send the documents for proper verification. In meanwhile the file may be kept in custody."

In view of the above, copy of Building Completion Certificate submitted by the institution is enclosed herewith.

It is kindly requested that the above Building Completion Certificate may kindly be verified for their authenticity that the same have been issued by the authorities mentioned therein. The information may kindly be sent at the earliest, so that necessary action could be initiated against the institution which have submitted false documents besides taking other criminal action.


