Sir/Madam,

I am to inform you that the case of your institution for grant of recognition for D.El.Ed. course was placed before WRC in its 263<sup>rd</sup> meeting held on November 25-27, 2016 and the Committee decided as follows:-

"...Clarification letter was issued on 14/06/2016 and reply was received on 03/08/2016. The clarification related to the composite nature of the college. The Society vide its reply stated that their D.Ed. college is in the name of "Balaji B.Ed. College" and they have submitted an application to the Higher Dept. M.P. for change of name to "Satguru Shiksha Mahavidhyalaya".

The institution has also stated that they are in the process of changing land and other documents. It also stated they have submitted a fee of Rs. 1.50 lakhs for change of the name of the B.Ed. college. However, a perusal of the file shows that there is no application for change of name nor the required fee.

In the absence of the above documents, the application for the D.El.Ed. course cannot be considered.

The Society is required to comply with this requirement within 30 days."

In view of the above, you are requested to submit the reply alongwith supporting documents within 30 days for further processing of the case.

In the event of this office not receiving any representation within 30 days of the issue of this letter, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
