SHOW CAUSE NOTICE


WHEREAS, recognition was granted to SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, RUN BY SHRI SANT KARTAR SINGH KALYAN SAMITI, NEHRU COLONY, THATIPUR, GWALIOR -474011, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting D.Ed. course vide order dated 14.08.2008 for an annual intake of 50 seats.

AND WHEREAS, after notification of NCTE Regulations, 2014, a letter dated 15.01.2015 was issued to the institution forwarding proforma of Affidavit to express their willingness to adhere to the new Norms in all respects such as duration of the course, size of the basic unit, requirements of staff, infrastructure, instructional facilities, NOC from the State Government, etc. and to give their consent for processing their application under Regulation 2014. In response, the affidavit was submitted by the institution on 08.01.2015.

AND WHEREAS, the institution applied on 17.09.2015 for change of premises from SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, RUN BY SHRI SANT KARTAR SINGH KALYAN SAMITI, NEHRU COLONY, THATIPUR, GWALIOR -474011, MADHYA PRADESH to SHRI SAI NATH SHIKSHA MAHAVIDHYALAYA, SURVEY NO.552, VILL. PURASANI, THATHIPUR, DIST. GWALIOR, MADHYA PRADESH.

AND WHEREAS, the matter was placed before WRC in its 234th meeting held on November 3-5, 2015 and the Committee observed that "...The institute has not submitted originally certified copy of the land document, notarized copies of Change of Land Use Certificate, Building Plan, Building Completion Certificate, and Non-Encumbrance Certificate. Hence, Show Cause Notice be issued on the above grounds."

In view of the above, Show Cause Notice is being issued to the institution. Your written representation with supporting documents should reach this office within 30 days from the date of this Notice. In case no representation is received within the stipulated time, it will be presumed that you have nothing to offer and in that event the WRC shall taken action as it deems fit and proper.
