SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution namely SHRI MAA BAGULA MUKHI COLLEGE OF EDUCATION, PLOT NUMBER : 8,22, STREET NUMBER : 02, VILLAGE : RAMDEVA, POST OFFICE : RAMDEVA, TEHSIL/TALUKA : INDERGARH, TOWN/CITY : DATIYA, DISTRICT : DATIA 475661, MADHYA PRADESH under section 14(3)(a) of NCTE Act, 1993 for conducting D.El.ED course of two years duration with an annual intake of 50 students vide order dated 12.02.2014.

AND WHEREAS, various complaints have been received that 27 teacher training institutions have been granted recognition by WRC office on the basis of fake staff profiles. It is being alleged that Shri Akhil Shrivastava & Shri Ajay Kumar Shrivastava signed and approved staff profiles of some private colleges, without having power to approve the staff profiles of the institutions applying for grant of recognition for D.El.Ed. Course.

AND WHEREAS, complaints and staff profiles of those institutions were forwarded to Principal, Govt. College of Education, Gwalior for verification and comments, vide letter dated 07.11.2014. As reply was not received, Reminder-I was sent vide letter dated 21.11.2014 and Reminder-II was sent vide letter dated 10.04.2015.

AND WHEREAS, reply received from the Principal, Govt. College of Education, Gwalior vide letter dated 26.06.2015.

AND WHEREAS, the matter was placed in the 253rd meeting of WRC held on May 24-26, 2016 and it was decided that, "Confirmed by the Principal, Govt. College of Education, Gwalior, the WRO should cross verify from the file. If found correct, no further action is required. If discrepancy is found, the matter be brought to the notice of WRC."

AND WHEREAS, reply received from the Principal, Government College of Education, Gwalior vide letter dated 24.06.2016, that the staff list submitted by the institution is not approved by the Government College of Education, Gwalior.

AND WHEREAS, the matter was placed before WRC in its 259th meeting held on September 21-23 2016 and the Committee decided that "**Show Cause Notice be issued for staff. The reply should be received within 15 days.**"

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 17 of the NCTE Act, 1993 giving an opportunity for making a written representation within a period of 15 days from the date of issue of this notice. In the event of this office not receiving any representation within 15 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.


