SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **AMPLE DREAMS EDUCATION SOCIETY, VILLAGE: UDPURA, STREET/ROAD: S H 18, TALUKA/MANDAL: SEHORE, TOWN/CITY: UDPURA, DISTRICT: SEHORE-466001, MADHYA PRADESH** had submitted the application on **28.05.2016** to the Western Regional Committee of the NCTE for grant of recognition for **B.A.B.Ed.** integrated course of 4 years duration.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 264th meeting of the WRC held on December 14-15, 2016 it was decided as under:

"The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

AND WHEREAS, the Visiting Team visited the institution on 25.02.2017.

AND WHEREAS, the visiting team report alongwith other document, were placed before WRC in it's 273rd meeting held on April 18-19, 2017. The committee decided that:-

"...The VT visited the insatution on 25/02/2017. The CD was seen and VTR perused. The CD shows a good building with adequate instructional and infrastructural facilities. The VT has recommended the case."

Hence, LOI be issued for 2 units of the B.A.B.Ed. course.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018." Accordingly Letter of intent was issued to the institution on 21.04.2017

AND WHEREAS, the reply of Letter of intent not received. The matter was placed before WRC in its 288th meeting held on February 15-16, 2018. The Committee decided that *"....LOI was issued to the institution on 21.04.2017. The reply to LOI is not received till date."*


Hence, Show Cause Notice be issued as to why recognition should not be refused. Reply should be submitted within one month."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
