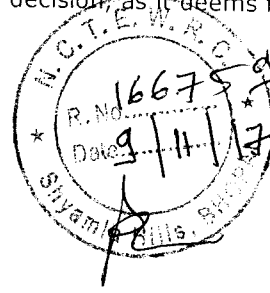
**SHOW CAUSE NOTICE**

WHEREAS, the recognition was granted to the institution namely, SBS COLLEGE, SURVEY NO. 585, PATWARI HALKA NO.27, VILLAGE-585, STREET/ROAD-NH 75, TALUKA/MANDAL- NEAR ANGOORI BARAAJ, TOWN/CITY/DISTRICT-DATIA, PINCODE- 475661, MADHYA PRADESH for D.El.Ed. course vide order dated 05.05.2017 for an annual intake of 100 seats.

AND WHEREAS, WRC, NCTE vide letter No.WRC/NCTE/RD/2017/188260 dated 9<sup>th</sup> August, 2017 forwarded copies of minority certificates submitted by the institutions, which have been granted recognition for D.El.Ed. course, to National Commission for Minority Educational Institutions, New Delhi for confirmation, that these certificates have been issued by their office as per the Number and date mentioned in the minority certificates.

AND WHEREAS, the matter was placed before the WRC in its 282<sup>nd</sup> meeting held on October 24-26, 2017 and the Committee decided that "...WRC had granted recognition to 16 institutions on the basis of the minority certificates submitted by the institutions. These minority certificates were forwarded to the National Commission for Minority Educational Institutions, New Delhi for confirmation. The National Commission for Minority Educational Institutions, New Delhi vide letter dated 19.09.2017 has confirmed the minority status to only seven of these sixteen institutions. **Hence, Show Cause Notice be issued to the rest of the following nine institutions, as to why recognition should not be withdrawn. Reply should be submitted within one month.**"

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 17 of the NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision as it deems fit and proper.
