Show Cause Notice

Whereas, in terms of Section 14 of the NCTE Act, SARASWATI BED COLLEGE RUN BY SANATAN BRAHM MAHAVIDHYALAYA SAMITI, PLOT NO. – 873, 874, VILLAGE – BADOKHAR, P.O. + TEHSIL + DIST. – MORENA – 476001, MADHYA PRADESH had submitted the application on 28.12.2012 to Western Regional Committee of the NCTE for grant of recognition for starting the **B.ED. (CO-ED)**.

AND WHEREAS, the hard copy of the application was received on 08.01.2013 and the application was processed.

AND WHEREAS, the Deficiency Letter was issued on 03.06.2013. The institution did not submit the reply.

AND WHEREAS, the matter was placed in 193rd Meeting held on November 11-13, 2013 of WRC and the Committee decided that “...No reply has been received to the Deficiency Letter. Hence, Show Cause Notice be issued to the institution.”

AND WHEREAS, the SCN was issued on 05.12.2013 and the reply of SCN was received on 09.01.2014.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 24.12.2014 and the reply was received on 03.02.2015 but the Affidavit was not in the proper format.

AND WHEREAS, a letter was issued to the institution on 19.03.2015 for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 in proper format and the reply was received on 27.03.2015.

AND WHEREAS, the matter was placed in 225th Meeting held on May 14, 2015 of WRC and the Committee decided that “...Show Cause Notice dated 05.12.2013 was issued. In response, the applicant has submitted the documents, which are in order. Hence, VT be constituted. The WRO should obtain the current FDRs.”

AND WHEREAS, the Inspection letter was sent to the Institution & VT members on 18.05.2015, inspection conducted by VT members on 30.05.2015 and the VT report/letter received in WRC on 04.06.2015.

AND WHEREAS, the matter was placed in 228th Meeting held on June 15-16, 2015 of WRC and the Committee decided that “...The VTR was perused and the CD was seen. The CD shows an adequate building with good physical and academic infrastructure. The VT has recommended the case.

Hence LOI under Clause 7(13) of NCTE Regulations, 2014 can be issued to the institution for two units of B.Ed. (50 each), after receipt of FDR for Rs.4.00 lakhs and Affidavit consenting to function under NCTE Regulations, 2014 in the correct format.

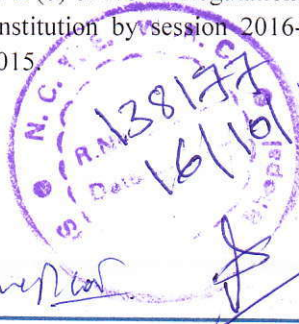
The Management also be advised to complete the formalities required after issue of LOI as per Appendix-4 of NCTE Regulations, 2014.

The attention of the institution should also be drawn to clause 2 (b) of NCTE Regulations, 2014, according to which every teacher training institution has to be a composite institution by session 2016-2017, as stipulated in the guidelines issued by the NCTE hqrs vide letter dated 06.02.2015

AND WHEREAS, the Letter of Intent was issued on **25.06.2015**. The institution did not submit the reply.

AND WHEREAS, the matter was placed in **232th Meeting held on September 16-17, 2015** of WRC and Committee decided that "...LOI was issued to the institution in June, 2015. The institute has not replied so far.

Hence, Show Cause Notice be issued to the institution."

Now therefore, this Show Cause Notice is issued to the institution u/s 14 of NCTE, Act, 1993 giving an opportunity for making representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.
