SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SIDDHI VINAYAK COLLEGE OF EDUCATION, PLOT/KHASRA NO.1858/53/1, STREET/NUMBER - SATAI ROAD, VILLAGE - BAGOUTA CHHATARPUR, POST OFFICE/TEHSIL/TALUKA /TOWN/CITY/DISTRICT - CHHATARPUR, PIN CODE - 471001, MADHYA PRADESH had submitted the application on 31.12.2012 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 05.03.2013 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal vide letter dated 25.04.2013 has given negative recommendation.

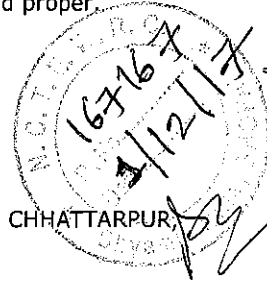
AND WHEREAS, the matter was placed before the WRC in its 183rd WRC meeting held on May 9-10, 2013 and the Committee observed that "...As per clause 7(2)(3) of NCTE Regulations, 2009, it is mandatory to request the concerned State Government to give their opinion/ recommendation on the opening of a teacher education course in private institutions. This Regulation had been further confirmed by the Hon'ble Supreme Court vide its judgment dated 31.01.2011 in SLP No.17165-168/2009. The ruling in this case has been reiterated in the letter No.49-7/2012/NCTE/N&S dated 20.03.2013, of the Member Secretary, NCTE Hqrs. In the present case, the Society - Pt Lt Shri Lalluram Shiksha Avam Jankalyan Sewa Samiti, Chhatarpur had applied for opening new D.El.Ed. (Co-Ed) course in Siddhi Vinayak College of Education, Chhatarpur. The State Government through the Rajya Shiksha Kendra vide their letter No.1290 dated 25.04.2013 has informed that in Chhatarpur district already 07 private institutions are conducting the D.Ed./ D.El.Ed. courses. Hence, opening of new course has not been recommended in Chhatarpur district. The application cannot be considered for Recognition. Hence, it is rejected." Accordingly, Rejection order was issued on 04.06.2013.

AND WHEREAS, the institution had filed W.P. No. 5313/2015 before Hon'ble High Court of Madhya Pradesh, Principal seat at Jabalpur and the Hon'ble High Court had passed an order dated 20.04.2015.

AND WHEREAS, the aforesaid court order was placed in the 283rd WRC meeting held on November 14-15, 2017 and the Committee decided that "...An examination of the file shows that the institution has not submitted CLU nor the latest premium paid receipt. The institution has also not submitted Building Completion Certificate and non-encumbrance certificate. Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month."


NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
