SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, SHRI RAMA KRISHNA CHARITABLE TRUST, PLOT NO.84, 85, 86/2, STREET/ROAD - NEAR SAHARA CITY SOHAWAL, VILLAGE/TOWN/CITY - KARHI PAWAI SOHAWAL, POST OFFICE - SOHAWAL, TEHSIL/TALUKA - RAGHURAJNAGAR, DISTRICT - SATNA, PIN CODE - 485001, MADHYA PRADESH had submitted the application on 15.05.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.EL.ED Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 10.07.2015 requesting to give their recommendation/comments. Reply from the State Government was not received. Hence, reminders were issued on 27.10.2015 and 09.12.2015, but still no reply was received. Recommendation of the State Government is not received but period of 90 days is over.

AND WHEREAS, the matter was placed before the WRC in its 239th WRC meeting held on January 6-8, 2015 and the Committee observed that "...The applicant is already recognized for two units of B.Ed. and now applied for D.El.Ed. course and B.A. B.Ed./B.Sc. B.Ed. An examination of the documents shows the following lacunae:-

- (i) Originally certified copy of the land documents not submitted; and
- (ii) Originally notarized copies of CLU, building plan, building completion certificate, non-encumbrance certificate not submitted.

Hence, Show Cause Notice be issued on the above grounds...."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.

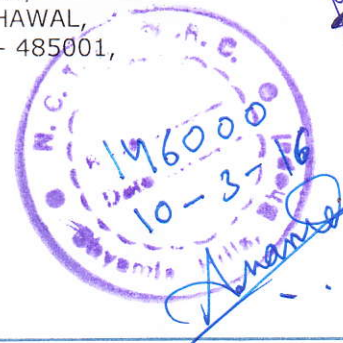
