I am to inform you that the case of your institution for **B.Ed.** Course was placed before the WRC in its 267<sup>th</sup> Meeting held on **January 23-25, 2017** and the Committee decided as under: "...Clarification letter was issued to the institution on 03/01/2017 for obtaining a fresh CD and the institution replied on 09/01/2017.

The VT visited the institution on 26/08/2016 and 27/08/2016. The VTR was perused and the CD which was resubmitted was viewed. The CD shows a good building with sufficient instructional and infrastructural facilities. The VT has recommended the case.

However, LOI for 2 units of the B.Ed. course will be issued by the WRO as soon as the institution submits the latest premium receipt for the CLU.

**The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 3<sup>rd</sup> March, 2017, can the case be considered for the session 2017-2018."**

In view of the above, you are requested to submit a reply within **15 days** from the date of issue of this letter.

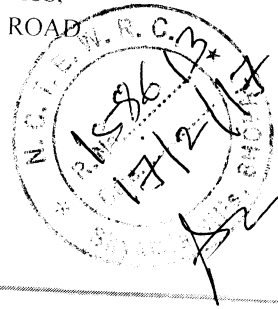
