SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993. GYANVEER INSTITUTE OF MANAGEMENT AND SCIENCE, PLOT NO: 211, VILLAGE: SAGAR, POST OFFICE: SAGAR, IEHSIL: SAGAR, DISTRICT: SAGAR-470001, MADHYA PRADESH had submitted the application on 25.05.2015 to the Western Regional Committee of the NCTE for grant of recognition/permission for B.Ed. part-time course of 3 years duration.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 14.07.2015 requesting to give their recommendation/comments.

AND WHEREAS. Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the WRC in its 241st meeting held on February 4-6. 2016 decide that WRO should process the case and constitute VT issued Show Cause Notice, as the case may be.

AND WHEREAS, the application was scrutinize and following deficiencies/shortcoming were observed:-

- 1. Address mentioned in Society Registration Certificate & Bye-Laws does not match with Online Application Form.
- 2. Photocopy of Building Plan submitted but notarized copy not submitted.
- 3. Building Completion Certificate not approved by Competent Authority & only photocopy submitted, notarized copy not submitted.
- 4. In Building Plan & Building Completion Certificate, Built-Up Area is less as per NCTE norms.
- 5. Photocopy of Change of Land Use Certificate submitted but notarized copy not submitted.
- 6. Notarized copy of Non-Encumbrance Certificate not submitted.
- 7. FDRs not submitted as per NCTE norms.
- 8. In Online Application Form & as per office record, institution has not applied for /nor conducting any other Teacher Education Course. Hence, institution is not fulfilling Clause 2(b) of NCTE Regulations, 2014.

AND WHEREAS. the Show Cause Notice was issued to the institution on 10.02.2016 on above ground and reply received on 01.03.2016.

AND WHEREAS, the matter was placed before the WRC in its 248th Meeting held on April 11-12, 2016, the committee observed that:- The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR.

AND WHEREAS, the RD WRO constituted the visiting team.

AND WHEREAS, the inspection letter issued to the institution on 22.04.2016 and the inspection conducted of

AND WHEREAS, the matter was placed before the WRC in its 260^{th} Meeting held on October 13-15, 2016, the committee observed that:-

"....The VT visited the institution on 25/04/2016. The CD was seen and VTR perused. The CD shows a good building with good infrastructural and instructional facilities. However, the VT has made the following observations:-

- a) Only few of the existing staff were available in the college. Students were not seen.
- b) When the VT asked for original documents for verification, the Chairman of the Society threatened them. This is a very serious allegation.
- c) Attendance Registers of the students were not available for verification.
- d) Although the Library had 14,000 books, only 3020 related to Education which is much less than the requirement for so many courses as per NCTE Regulations, 2014.

Hence, Show Cause Notice be issued on the above grounds.

Further, the institution is required to send the latest copies of staff profile approved by the competent authorities for the D.Ed. (222121 & APP2046), B.Ed. (223075) and M.Ed. (225127) courses.

The salary statement for the above staff certified by the Bank in original should be submitted for the months of January to March, 2016.

The reply to the above should be submitted within 15 days."

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14 (3) (b) of NCTE Act. 1993 giving an opportunity for making a written representation within a period of 15 days from the date of issue of this notice. In the event of this office not receiving any representation within 15 days of the issue of this notice it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
