WHEREAS. in terms of Section 14 of the NCTE Act, 1993. ANGIRA COLLEGE OF EDUCATION, PLOT/ KAHSRA NO- 147/529/2, 147/530, VILLAGE- NIWARI BHATA, STREET NO: NH-76, POST OFFICE- NIWARI, TEHSIL- NIWARI, DISTRICT: TIKAMGARH- 472442, MADHYA PRADESH had submitted the application on 30.05.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS. Department of Higher Education. M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 235th Meeting held on November 23-24, 2015 and the Committee observed that "...The College applied online on 30.05.2015. However, the hard copy was received on 15.07.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS, the Rejection Letter was issued on 03.12.2015 and Appeal order dated 02.06.2016 was received on 14.06.2016 remanding the case to WRC.

AND WHEREAS, the matter was placed before the WRC in its 261st Meeting held on October 26-28, 2016 and the Committee observed that "...This is a case of Appeal. The Appellate Authority vide letter dt. 02/06/2016 has remanded the case to WRC for further processing.

The RD WRO should get this case processed and should put them in the next meeting."

AND WHEREAS, the matter was placed before the WRC in its 263<sup>rd</sup> Meeting held on November 25-27. 2017 and the Committee observed that "...An examination of the file shows that the institution has not submitted originally certified copy of land documents, notarized copy of CLU and Non-Encumbrance Certificate. Further, it seen that the institution is having land area of 1.063 প্রসারতত্ত equivalent to 1700.8 sq. mtrs. which is grossly inadequate to run D.El.Ed. as well as B.A.B.Ed./B.Sc.B.Ed. courses.

The built up area is not seen in the Building Plan nor has the Building Completion Certificate been submitted. So it is not possible to determine how much built up area the institution is having for running the D.El.Ed. and the B.A.B.Ed./B.Sc.B.Ed. courses. The original Affidavit and the NOC from the affiliating have also not been submitted.

The same documents are submitted for the D.El.Ed. course. Neither the land nor the built up area are sufficient to run the B.Ed. and the D.El.Ed. courses.

Hence, Show Cause Notice be issued on the above grounds to the B.Ed.(APP2915), B.A.B.Ed. /B.Sc.B.Ed.(APP201660103) and D.El.Ed.(APP2425) courses. The reply be submitted within 30 days."

AND WHEREAS. Show Cause Notice was issued to the institution on 30.11.2016 and the institution has not wubmitted the reply till date.

AND WHEREAS, in D.El.Ed. course (APP2425), the original file, visiting team and other relevant documents were considered by WRC in its 265<sup>th</sup> Meeting of WRC held on December 27-29. 2016 and the Committee decided that "...This case will be considered after receiving the Report from the SDM. Jatara regarding the complaint about the building." Accordingly, letter to the Collector was issued on 31.10.2016."

**AND WHEREAS,** in D.El.Ed. course (APP2425), the reply received from the Tehsildaar. Tikamgarh and the reply was placed before the WRC in its 267<sup>th</sup> Meeting held on January 23-25, 2017 and the Committee observed that "...The institution has applied for the D.El.Ed. (APP2425), the B.Ed. (APP2915), and B.A.B.Ed./B.Sc.B.Ed. (APP201660103) courses.

The VT had visited the institution first on 13/04/2015 but the management refused to get the inspection done. Thereafter, after the institution submitted the fee for re-inspection on 17/04/2016, VT was then constituted and inspected the institution on 02/05/2016 for the D.El.Ed. and B.Ed. courses. The VT report was perused and the CD viewed.

Before a decision could be taken, a complaint was received on the land and building. The complaint was then referred to the Collector. Tikamgarh and the report from the Tehsildar dt. 30/12/2016 was received together with a CD.

The CD submitted by the VT shows a building that is completed with Labs and Library inadequately equipped. However, the CD submitted by the Tehsildar shows a G+3 story building under construction. There are no facilities in this building. The Tehsildar has also mentioned that a part of the construction is in survey no. 148 which is under dispute.

It is evident that the institution tried to mislead the VT.

Hence, Show Cause Notice be issued to the institution on the above grounds as to why the recognition should not be refused.

Reply should be submitted within 30 days."

**NOW THEREFORE.** this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act. 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
