**SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SHARDA INSTITUTE OF TEACHERS EDUCATION, STREET/ROAD: RATIBAD ROAD, VILL.: BARKHEDIKALAN, P.O.: SURAJ NAGAR, TEH./TAL.: HUZUR, TOWN/CITY: BHOPAL, DIST.: BHOPAL - 462044 MADHYA PRADESH had submitted the application on 12.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed./B.Sc.B.Ed. Course of 4 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 15.07.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 236th meeting held on December 15-16, 2015 and the Committee observed that "...The case under consideration at present is an application for B.A. B.Ed./B.Sc. B.Ed. under APP2960. The WRO has informed that there is another application for B.Ed. under APP2961. So the land area and built up area requirement is as per para 6.1 of Appendix-2 of NCTE Regulations, 2014. An examination of the documents shows that the built up available area is 2845.95 sq. mts., whereas the requirement is of 3000 sq.mts. Originally notarized copy of building completion certificate has not been submitted.

**Hence, Show Cause Notice be issued on the above grounds.**

The Department of Higher Education, Govt. of M.P. has not recommended the case on the ground that it is not a composite institution. It is observed that the applicant has simultaneously applied for B.Ed. course. Thus the intention of the institution to become a composite institution is there. Hence, this negative recommendation is not accepted.

**It is necessary to mention that though the applicant has mentioned both the integrated courses, the University has given an NOC for only B.A. B.Ed. and B.Ed. course. Hence, the case will be processed along these lines."**

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
