

SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, APS MAHAVIDHYALA, PLOT NO.: 2/10, STREET/ROAD: MAIN ROAD VILL.: BUDAUR, CHHATARPUR, P.O.: CHHATARPUR, TEH./TAL.: CHHATARPUR, TOWN/CITY: CHHATARPUR, DIST.: CHHATARPUR – 471001 (MP) had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed./B.Sc.B.Ed. Course of 4 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 22.07.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 237th meeting held on December 21-22, 2015 and the Committee observed that "...The applicant has recently been Recognized for B.Ed. course and now has applied for B.A. B.Ed./B.Sc. B.Ed. The applicant has to clarify which integrated course B.A. B.Ed. or B.Sc. B.Ed. it proposes to conduct. At the first instance, only one unit of 50 seats can be considered for Recognition.

On examination of the documents, it is noticed that:-

- (i) The applicant has submitted two land documents, according to which the total land area for recognized B.Ed. and proposed B.A. B.Ed./B.Sc. B.Ed. is sufficient. However it is not clear whether the two pieces of land are adjacent/ contiguous to each other;
- (ii) Further, the land documents are not originally certified by the Revenue Authority;
- (iii) Building plan approved by the competent authority not submitted;
- (iv) The other documents viz. Certificate of registration of Society, bye-laws, memorandum of association building completion certificate, non-encumbrance certificate though submitted, are not originally notarized;
- (v) FDRs not submitted as per NCTE Regulations, 2014; and
- (vi) The Department of Higher Education, Govt. of M.P. has not recommended the case on the ground that it is not a composite institution.

Hence, Show Cause Notice be issued on the above grounds."


NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
