**SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993 SAISAGAR COLLEGE OF EDUCATION, PLOT/KHASARA NO- 414, 412/2, STREET-ADITYA PURAM, VILLAGE- JADERUA, POST OFFICE- PINTO PARK, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR-474020, MADHYA PRADESH had submitted the application on 29-06-2015 to the Western Regional Committee of the NCTE for grant of recognition for B.ED.Course of 2 years duration.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the application was scrutinized and following deficiencies have been observed :-

- **Society Registration Certificate & Bye-Laws not submitted.**
- **Address of the institution not mentioned in NOC of University/Affiliating Body.**
- **Khasra No. 412/2 not mentioned in the Affidavit.**
- **Photocopy of Building Plan submitted but Blue Print/notarized copy not submitted.**
- **Notarized Copy of Building Completion Certificate not submitted.**
- **Notarized Copy of CLU not submitted.**
- **FDRs not submitted, as per NCTE Regulation, 2014.**
- **In online Application Form, Applied/Existing course not mentioned but as per our record, the institution is Applied for D.P.S.E.Course-(APP3198).**
- **Proof of running the BA, BBA, PGDCA Courses not submitted.**

In 241<sup>st</sup> Meeting of the WRC held on February, 04-06, 2016, it was decided that WRO should process the case and constitute VT / issue SCN, as the case may be.

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 on the above points-giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
