SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, Saisagar College of Education, Plot/Khasara No.: 414, 412/2, Aditya Puram, Vill.: Jaderua, P.O.: Pinto Park, Tehsil + City: Gwalior, Dist.: Gwalior 474020, Madhya Pradesh had submitted the application on 10.07.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.P.S.E. course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 29.09.2015 requesting to give their recommendation/comments.

AND WHEREAS, in 241th meeting of the WRC held on February 04-06, 2016 it was decided as under:
“...The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC.”

Hence, in view of the above, Show Cause Notice is issued on the following points:-

- 1 Change of Land Use certificate issued by Sub-Divisional Officer, not submitted, it should be notarized.
- 2 Notarized copy of Building plan approved by competent authority not submitted.
- 3 Building Completion certificate issued by Govt. Engineer (RES) not submitted, it should be Notarized.
- 4 Society registration certificate, Memorandum, By-laws of the society / trust are not submitted. It should be notarized.
- 5 FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
- 6 Institution does not fulfill the norms as per clause 2(b) and 3(a) of NCTE Regulations, 2014, according to which every teacher training institution has to be a composite institution.

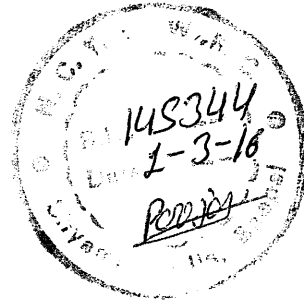
NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15 (3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
