SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, GS Institute, Plot No.: 100/2, Vill.: Ragauliya, P.O. + Teh./Tal.: Chhatarpur, Dist.: Chhatarpur 471001, Madhya Pradesh had submitted the application on 09.07.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed. & B.Sc.B.Ed. Integrated course of 4 years duration with an annual intake of 50 students.



AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 28.01.2016 requesting to give their recommendation/comments.

AND WHEREAS, in 241th meeting of the WRC held on February 04-06, 2016 it was decided as under:
"...The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

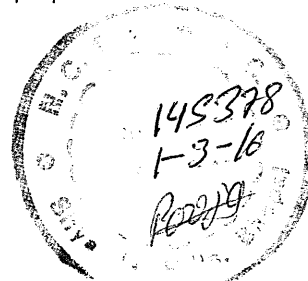
Hence, in view of the above, Show Cause Notice is issued on the following points:-

1. Originally certified copy of registered land documents not submitted.
2. Originally notarized copy of Change of Land Use certificate issued by Sub-Divisional Officer not submitted.
3. Originally notarized copy of Non-Encumbrance certificate issued by Tehsildar, SDO, or Sub-Registrar not submitted.
4. Notarized copy of Building plan approved by competent authority not submitted.
5. Notarized copy of Building Completion certificate issued by competent authority not submitted.
6. Affidavit in the prescribed format on Rs.100/- stamp paper duly attested by oath commissioner or Notary Public as required under provision of section 7 (1) of NCTE, Regulations, 2014 submitted. But point No. 5 not filled.
7. Copy of Registration, Memorandum, By-laws of the society / trust is not submitted.
8. FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
9. NOC from affiliating body not submitted.
10. Institution does not fulfill the norms as per clause 2 (b) and 3(a) of NCTE Regulations, 2014, according to which every teacher training institution has to be a composite institution.
11. The Institution is also directed to clarify for which course it has applied, i.e. for B.A. B.Ed or B.Sc. B.Ed.

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15 (3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
