SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, SHRI RADHA KRISHNA AKASHR VIKAS NYAS, PLOT NO.104/3, STREET/ROAD - ESHGARH ROAD, VILLAGE/TOWN/CITY/ POST OFFICE/TEHSIL/TALUKA/ TOWN/CITY/DISTRICT - ASHOK NAGAR, PIN CODE - 473331, MADHYA PRADESH had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition in D.El.Ed Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 29.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 19.01.2016 has given their recommendation.

AND WHEREAS, in the 241st meeting of WRC held on February 4-6, 2016, it was decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be. Accordingly, Show Cause Notice was issued on 10.02.2016.

AND WHEREAS, the reply received from the institution was placed in the 248th Meeting of WRC held on April 11-12, 2016 and the Committee decided that "...In response to the Show Cause Notice issued to the Society on 17/03/2016, the Society has submitted the land documents, building plan, the photocopies of the CLU and Building Completion Certificate. Notarized copy of the Non-Encumbrance Certificate has not been submitted. The Society has also not submitted the NOC from the affiliating body but the case is being processed further in view of the direction issued in the SLP No. 7461/2016 pending before the Hon'ble Supreme Court. The Committee decided to constitute VT. It should be instructed to obtain the notarized copy of the Building Completion Certificate, CLU and Non-Encumbrance Certificate from the Society and submit it with the report."

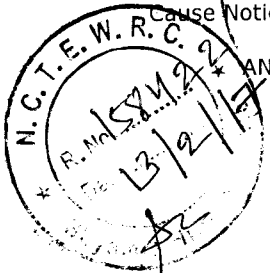
AND WHEREAS, the inspection of the institution was conducted on 18.04.2016.

AND WHEREAS the original file, visiting team and other relevant documents were considered by WRC in its 250th Meeting of WRC held on April 27-28, 2016 and the Committee decided that "...The VT visited the institution on 18/04/2016 and submitted the report alongwith the CD. The VT report was perused and CD was viewed. On perusal of the CD, it has been found that the half part of the building looks as abandoned structure. Though the institution already houses B.Ed. course but it does not reflect the academic ambience. Whitewashing of the building has not been done properly and the playground has not been leveled. Hence, Show Cause Notice be issued on the above grounds." Accordingly, Show Cause Notice was issued on 05.05.2016.

AND WHEREAS, the reply received from the institution was placed in the 263rd Meeting of WRC held on November 25-27, 2016 and the Committee decided that "...In the 248th meeting, the WRC decided to constitute VT and the VT was instructed to obtain notarized copies of Building Completion Certificate, CLU and Non-Encumbrance Certificate from the Society. The VT obtained the CLU and the Building Completion Certificate. In the 250th meeting, the WRC decided to issue Show Cause Notice on the ground that the CD showed half part of the building as abandoned structure and whitewashing of the building had not been done properly. The institution has replied saying that they have attended to the works as pointed out in the Show Cause Notice. However, to confirm the same since it pertains to the building, a VT be constituted."

AND WHEREAS, the inspection of the institution was again conducted on 10.12.2016.

AND WHEREAS the original file, visiting team and other relevant documents were considered by WRC in its 267th Meeting held on January 23-25, 2017 and the Committee decided that "...The VT visited the institution on 10/12/2016. The VTR was perused and the CD viewed. The CD shows a building with insufficient instructional and infrastructural facilities. The Labs are inadequate. The premium receipt for the CLU has not been submitted. The Patwari halka map showing the contiguity of plot areas has not been submitted. No journals and magazines are subscribed by the college. Building Completion Certificate from the competent authority has also not been submitted. **Hence, Show Cause Notice be issued to the institution as to why the Recognition should not be refused on the above grounds. Reply should be submitted within 30 days.**"


NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15(3)(b) of NCTE Act, 1993 on the above points giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
