SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, J J Institute of Teacher Education, Plot No.: 131, Vill.: Gathewra Chhatarpur, P.O. + Tehsil/Taluka + City: Chhatarpur, Panna Road, Dist.: Chhatarpur 471001, Madhya Pradesh had submitted the application on 14.07.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed. & B.Sc.B.Ed. Integrated course of 4 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 07.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in 241th meeting of the WRC held on February 04-06, 2016 it was decided as under:
"...The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

Hence, in view of the above, Show Cause Notice is issued on the following points:-


- 1 Notarized copy of Society registration certificate submitted. Memorandum, By-laws of the society / trust are not submitted.
- 2 Originally certified copy of registered land documents not submitted.
- 3 Originally notarized copy of Change of Land Use certificate issued by Sub-Divisional Officer, Chhatarpur submitted. Total Diverted land area is 0.310 hect. (3100 Sq. mtr) which is less as required for running D.Ed (222523) & proposed B.Sc.B.Ed./B.A.B.Ed.
- 4 Notarized copy of Building plan approved by competent authority not submitted.
- 5 Notarized copy of Building Completion certificate issued by Govt. Engineer (RES) not submitted.
- 6 Originally notarized copy of Non-Encumbrance certificate issued by Sub-Registrar/ Revenue authority not submitted.
- 7 FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
- 8 The Institution is also directed to clarify for which course it has applied, i.e. for B.A. B.Ed or B.Sc. B.Ed.

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15 (3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
