**SHOW CAUSE NOTICE**

**WHEREAS**, in terms of Section 14 of the NCTE Act, 1993, **MADHUBAN COLLEGE OF EDUCATION, PLOT/ KHASRA NO- 118/6 & 121/8, HALKA NO- 13, VILLAGE- KASRAWAD, POST OFFICE- KASRAWAD, TEHSIL- BARWANI, CITY- BARWANI, DISTRICT: BARWANI- 451551, MADHYA PRADESH** had submitted the application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration with an intake of 02 units of 50 students each.

**AND WHEREAS**, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 gave its recommendation.

**AND WHEREAS**, the SCN was issued to the institution on **22.02.2016** and the reply of SCN was received on **21.03.2016**."

**AND WHEREAS**, the matter was placed before the WRC in its 256<sup>th</sup> Meeting held on July 19-21, 2016 and the Committee observed that "...Show Cause Notice dt. 22/02/2016 was issued. The documents were examined. It is seen that the land ownership document is only notarized, whereas it should be originally certified. But a more serious issue is that **this land was purchased after the date of online application**. In this context Clause 5(4) and 8(4)(i) of the NCTE Regulations, 2014 are relevant and quoted below :

**"Clause 5(4)** - While submitting the application online copy of registered land document issued by the competent authority, indicating that the Society or institution applying for the programme possesses land on the date of application shall be attached along with the application.

**Clause 8(4)(i)** - No institution shall be granted Recognition under these regulations unless the institution or Society sponsoring the institution is in possession of required land on the date of application. The land free from all encumbrances could be either on ownership basis or on lease from Government or Government institutions for a period of not less than thirty years."

Apart from the above, other lacunae in the file are:-

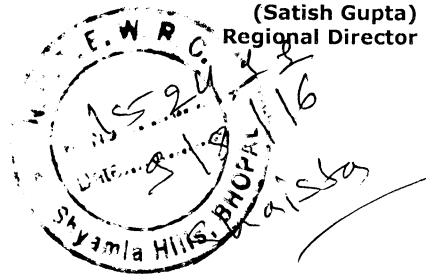
- The Building Completion Certificate is not in the proper format, nor certified by the competent authority;
- No proof has been submitted about the conduct of regular other courses. Distance education courses cannot be considered as regular courses for the purpose of Clause 2(b).

**Hence, another Show Cause Notice be issued on the above grounds."**

**NOW THEREFORE**, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 21 days from the date of issue of this notice. In the event of this office not receiving any representation within 21 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
