SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **JAGRITI SHIKSHA EVAM SAMAJ KALYAN SAMITI, PLOT/STREET/ROAD - RATAHARA, VILLAGE/TOWN/CITY/POST OFFICE - REWA, TEHSIL/TALUKA - HUZUR, DISTRICT - REWA- 486001 STATE - MADHYA PRADESH** had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for an annual intake of 50 students in D.El.Ed Course of 2 year duration.

AND WHEREAS, the matter was placed before WRC in its 234th meeting held on November 3-5, 2015 and the Committee decided that "...As per public notice dated 27.02.2015 applications were not invited for D.El.Ed. course from Madhya Pradesh except from 20 districts which were listed in the notification. The WRO presented a list of 30 applications submitted for the D.El.Ed. course in agenda no 13 which are from the districts from where applications were not to be accepted. The WRC, therefore, decided to return the applications to these institutions along with processing fee. Copies of the letters be sent to NCTE Hqrs for refund of fees." Accordingly, Application returned on 10.11.2015.

AND WHEREAS, the Hon'ble High Court of Madhya Pradesh, at Jabalpur in the context of Ambition College of Education, had passed an order dated 28.01.2016 in which it has been directed that, '...In our opinion, the condition specified in the impugned notification dated 27.02.2015 (Annexure-P/3) to exclude 20 districts of State of Madhya Pradesh from consideration, deserves to be quashed and set aside in terms of this order. In other words, all applications received before the cut off date including of the respondent No.1 from concerned twenty districts of State of Madhya Pradesh ought to be treated as valid and eligible to participate in the consideration process. Indisputably, the petitioner had submitted such application in response to the notification on 30.06.2015, which is within the extended cut off date(i.e. 30.06.2015). In that, the fact that the petitioner had submitted application on 30.06.2015 has not been disputed. For that reason, respondent No.1 and other statutory Authorities will be obliged to decide the application preferred by the petitioner and take a final decision thereon expeditiously and not later than 3rd March, 2016. If any other application has been received from the districts which were otherwise excluded in terms of the impugned notification, within specified time, even those applications be processed by the respondent No.1 and other statutory Authorities in accordance with law before 3rd March, 2016 and decision thereon be communicated to the concerned applicants. If the decision is adverse to the concerned applicants, they will be free to challenge the same on grounds as may be permissible in law...'

AND WHEREAS, the institution resubmitted the application to WRO on 02.03.2016 for reconsideration.

AND WHEREAS, the matter was placed in the 247th Meeting of WRC held on April 4-6, 2016 and the Committee decided that "...This case is being considered in conjunction with the application for B.Ed. course (APP3443) where a Show Cause Notice was issued on 16/02/2016 on the grounds that Building Completion Certificate has not been submitted and that the institution is not a composite one. Now that the application for the D.El.Ed. course from the same College is under consideration, the Show Cause point about composite nature of the College be dropped. The two applications are to be processed simultaneously. **Hence, VT be constituted for both the cases. However, NOC from the affiliating body should be submitted by the institution for the D.El.Ed. course. Letter to the State Govt. be sent seeking its recommendation as per clause 7(4) of the NCTE Regulations, 2014.**"

AND WHEREAS, the inspection of the institution was conducted on 14.04.2016.

AND WHEREAS, the original file, visiting team report and other relevant documents were considered by WRC in its 249th meeting held on April 21-23, 2016 and the Committee observed that "...VT was constituted and the VT visited the institution on 14/04/2016. However, the inspection could not be conducted as there was no response from the management. Further, the VT found that there was no building or any construction in the specified Khasra numbers. A Panchnama to this effect was submitted to the WRO. **Hence, Show Cause Notice be issued on the above ground.**"

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 on the above points giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
