## Show Cause Notice

Whereas, in term of Section 14 of the NCTE Act 1993 Suvidha Mahila Education College, At- Hedua-Rajger, Post. Sometra, Mehsana-384002, Gujarat was granted recognition for conducting B.Ed. course of one year duration with an intake of 100 students vide order No. WRC/5-6/40/2002 05843 dated 24.09.2002.

And whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

And whereas, Letter regarding acceptance and compliance of NCTE Regulations, 2014 was issued to the institution on 12.01.2015 for submission of affidavit in the prescribed format, failing which the revised order of recognition will not be issued and the recognition granted earlier will become invalid.

And whereas, the institution did not submit Affidavit for compliance of NCTE Regulations, 2014.

And whereas, Revised Recognition order was also not issued to the institution.

And whereas, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255<sup>th</sup> meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

In compliance of the decision of the WRC, the Show Cause Notice is issued to the institution under Section 17(1) of the NCTE Act, 1993. The institution is directed to submit written representation within a period of 21 days from the date of this Notice. In the event, this office does not receive any reply, it will be presumed that the institution has nothing to say and the Regional Committee shall take action for withdrawal of recognition

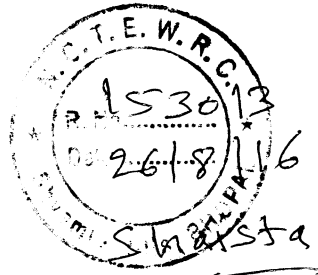
