**SHOW CAUSE NOTICE**

WHEREAS, recognition was granted to the institution namely, ANSH COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM, SAHABH KA BADA, MAMA KA BAZAR, MADHOGANJ, LASHKAR, GWALIOR, MADHYA PRADESH under section 14(3)(a) of NCTE Act, 1993 for conducting D.El.Ed course of two years duration with an annual intake of 50 students vide order dated 30.10.2006.

AND WHEREAS, ANSH COLLEGE OF EDUCATION, GWALIOR, MADHYA PRADESH had applied for shifting of premises on 15.06.2016

AND WHEREAS, the matter was placed in the 255<sup>th</sup> meeting of WRC held on June 22-24, 2016 and it was decided that, "...Show Cause Notice dt. 18/05/2016 was issued to the institution, on the basis of the observations made by the team of the NCTE Hqrs. (inspection done under Section 13 of the NCTE Act, 1993). The first point of the Show Cause Notice relates to the shifting of premises by the institution without prior permission of the WRC. From the reply of the institution, it is clear that the premises of the College were shifted without prior permission since the institution has now applied for shifting after depositing the process fee of Rs. 1.50 lakhs, alongwith supporting documents. These documents were examined. The land ownership document is not originally certified by the competent revenue authority, and the other documents are not originally notarized as is required. Unless the above defects are rectified, VT cannot be constituted. Hence, clarification be obtained on this ground. FDRs have been submitted. The third issue of the Show Cause Notice relates to payment of salary and other benefits to the staff as required under the rules. The institution has only submitted a statement showing the salary of one Principal and seven staff members, and the photocopy of a cheque for the amount of Rs. 1,46,336 - this amount is for 3 months (March to May, 2016) for 8 staff members. The above compliance is not sufficient. The institution has 2 units of B.Ed. according to NCTE Regulations, 2014, Appendix-4; an institution has to employ one Principal and fifteen assistant lecturers. Hence, the salary statement should have been for sixteen staff members. The attention of the institution be drawn to Clause 10(2) and 10(3) of the NCTE Regulations, 2014, which has mandatorily followed. For ready reference, this is reproduced below:

"Clause 10 - (2) The academic and other staff of the institution shall be paid such salary as may be prescribed by the concerned government or Board or affiliating body by account payee cheque or as per advice into the bank account of employee specially opened for the purpose. The institution shall maintain complete record of payment of salary to the employees, Employees Provident Fund, details of which may be given in the self appraisal report and which may be verified at any time by the Council of State Government or affiliating body.

(3) Every institution shall display on its official website, every financial year by the 30<sup>th</sup> day of September, the following statements of accounts duly certified by a Chartered Accountant :-

- (i) Balance sheet as on the last date of the financial year;
- (ii) Income and expenditure account for the financial year;
- (iii) Receipt and payment account for the financial year."

The institution must submit an Affidavit showing that the above Clauses are being complied with. One month's time is given to the institution for compliance of the above. RD/WRO to ensure." Accordingly, Clarification letter was issued on 12.07.2016.

AND WHEREAS, the reply received was placed in the 258<sup>th</sup> meeting of WRC held on August 22-24, 2016 and it was decided that, "...In response to the letter dt. 12/07/2016 to obtain clarification, the applicant has submitted the documents which are in order. Hence, VT be constituted. However, the following lacuna still remain:-

- i) For the D.Ed. course, no FDRs have been submitted;
- ii) For B.Ed also, only photocopy of FDR of Rs. 5 Lakhs is there. Original FDR in joint names has not been submitted; and
- iii) Bank Statement for salary of the employees showing details of EPF has not been provided.

The WRO/RD should ensure that these documents are obtained simultaneously." Accordingly, Clarification letter was issued on 26.08.2016.

AND WHEREAS, the inspection of the institution was conducted on 10.09.2016.

AND WHEREAS, the original file, visiting team and other relevant documents were considered by WRC in its 259<sup>th</sup> Meeting held on September 21-23, 2016 and the Committee decided that "...A letter seeking Clarification was sent to the institution on 26/08/2016 and reply was received 06/09/2016. The points of the reply are as under:

- i) FDRs : All the FDRs required are in the file.

Hence, no further action is required. The VT for shifting was also constituted on 10/09/2016 and Report was received subsequently. However, the CD was received in a damaged condition. Hence, the institution be asked to submit a fresh CD." Accordingly, letter was issued on 29.09.2016.

AND WHEREAS, reply received from the institution was placed in the 283<sup>rd</sup> WRC meeting held on November 14-15, 2017 and the Committee observed that "...This is a case of shifting. VT report was perused and the CD was seen. The CD shows a building with adequate infrastructural and instructional facilities. It has also been learned that the building earmarked for Ansh College of Education is also 'The Academy of Nursing Science and Hospital'. It may be clarified if the proposed shifting is to this institution of 'The Academy of Nursing Science and Hospital'. If so, the latest Building Completion Certificate, ear marking of built-up area of 3500 sq.mts. for the teacher education courses and the latest staff profile duly approved by the affiliating body be submitted for further processing of case. Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month."

NOW THEREFORE, in exercise the powers of vested with the Western Regional Committee an opportunity is hereby given to the said institution for making a written representation within 30 days of the issue of this notice before rejection of permission for change of premises on the grounds mentioned above.
