SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution, namely, GURU NANAK DEV COLLEGE OF EDUCATION, GOL PAHADIA ROAD, NEAR POWER HOUSE LASHKAR, GWALIOR, MADHYA PRADESH under section 14(3)(a) of NCTE Act, 1993 for conducting D.El.Ed. course of two years duration with an annual intake of 50 students vide order dated 15.02.2007.

AND WHEREAS, GURU NANAK DEV COLLEGE OF EDUCATION, GWALIOR, MADHYA PRADESH had applied for shifting of premises on 06.05.2016.

AND WHEREAS, the inspection of the institution was conducted on 23.01.2017.

AND WHEREAS, the original file, visiting team and other relevant documents were considered by WRC in its 283rd Meeting held on November 14-15, 2017 and the Committee decided that "...This is a case of shifting. An examination of the file shows that the institution has submitted three land documents, out of which, two are in the name of GyanMandir and one is in the name of 'Sarju Prasad Verma', which is not permitted. The available land in the name of GyanMandir is insufficient to run the D.El.Ed. course (The requirement is 2500 sq.mts.). CLU shows only diversion of 1680 sq.ft. which is grossly insufficient. Non-encumbrance certificate and Building Completion Certificate is not submitted. Additional FDR for Rs.4.00 lakhs not submitted. The building plan submitted with the VTR is of BJS college and not of GyanMandir. Another building plan is in the name of Guru Nanak Dev College of Education, where the total covered area is mentioned as 281.85 sq.mts. The CD was viewed. It shows an old building with infrastructure which appeared insufficient (library, laboratories). CD did not show the front elevation of the building and the multipurpose hall. In all, the members did not feel confident about the college and its infrastructure. **Hence, Show Cause Notice be issued on the above points as to why recognition should not be withdrawn. Reply should be submitted within one month.**"

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 17 of the NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
