SHOW CAUSE NOTICE

WHEREAS, the recognition was granted to the institution namely, **Jain College (Run by Manodeep Higher Edu. Soc.), Opp. Little Angels High School Gudi Guda Naka Road, Chirwai, Lashkar, Gwalior Madhya Pradesh** for **M.Ed. course** vide order dated 26.08.2008 for an annual intake of 25 students and enhancement of intake was permitted vide order dated 27.01.2011 from 25 to 35 seats.

AND, WHEREAS, WRC issued Revised Recognition Order to **Jain College (Run by Manodeep Higher Education Society), Opp. Little Angels High School Gudi Guda Naka Road, Chirwai, Lashkar, Gwalior - 474009, Madhya Pradesh** on 28.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (One basic unit) from the academic session 2015-16.

AND WHEREAS, the Show cause notice for Staff Profile for the session 2015-16 duly approved by the affiliating body, originally notarized CLU/NEC/BP and Building Completion Certificate was issued to the institution on 10.01.2017.

AND WHEREAS, the matter of the B.Ed. course (APW0639/223181) was considered by WRC in **287th meeting held on January 30-31, 2018** and the Committee decided that "...Show Cause Notice was issued to the institution on 06.09.2017 regarding submission of shifting fees, FDRs and staff profile as per NCTE Regulations, 2014. The institution has submitted an affidavit to abide by the NCTE Regulations, 2014 and revised order was subsequently issued. Now, the institution has said that these provisions do not apply for them.

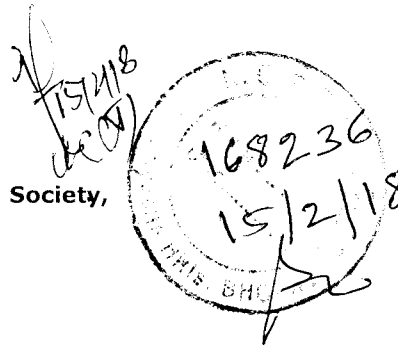
Hence, Recognition is withdrawn from the academic session 2018-2019.

Since, Recognition for the B.Ed. course has been withdrawn, Show Cause Notice be issued to the institution as to why Recognition for M.Ed. course (225081) should not be withdrawn. Reply should be submitted within one month."

Now, therefore this Show Cause Notice is issued u/s 17 of the NCTE Act, 1993 for submission of reply along with supporting document. Your written representation should reach this office within **30 days** from the date of this Notice. In case no representation is received within the stipulated time, it will be presumed that you have nothing to offer and in that event, the WRC shall taken action for withdrawal of recognition u/s 17 of the NCTE Act, 1993.
