#### SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SHRI BHAGWATI PREM SHIKSHA PRASAR **PLOT** NO.224, STREET/ROAD **HASANPURA** VILLAGE/TOWN/CITY/P.O. RATWAI, TEHSIL/TALUKA MORAR, VILLAGE/TOWN/CITY: RATWAI, POST OFFICE: MORAR TEHSIL/TALUKA: GWALIOR - 474006, MADHYA PRADESH had submitted the application on 29.05.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per public notice dated 27.02.2015 applications were not invited for D.El.Ed. course from Madhya Pradesh except from 20 districts which were listed in the notification. The application submitted by SHRI BHAGWATI PREM SHIKSHA PRASAR SAMITI, PLOT NO.224, STREET/ROAD HASANPURA ROAD, VILLAGE/TOWN/CITY/P.O. RATWAI, TEHSIL/TALUKA MORAR, VILLAGE/TOWN/CITY: RATWAI, POST OFFICE: MORAR TEHSIL/TALUKA: GWALIOR - 474006, MADHYA PRADESH was from the banned districts.

AND WHEREAS, the Hon'ble High Court of Madhya Pradesh, at Jabalpur in the context of Ambition College of Education, had passed an order dated 28.01.2016 in which it has been directed that, '...In our opinion, the condition specified in the impugned notification dated 27.02.2015 (Annexure-P/3) to exclude 20 districts of State of Madhya Pradesh from consideration, deserves to be quashed and set aside in terms of this order. In other words, all applications received before the cut off date including of the respondent No.1 from concerned twenty districts of State of Madhya Pradesh ought to be treated as valid and eligible to participate in the consideration process. Indisputably, the petitioner had submitted such application in response to the notification on 30.06.2015, which is within the extended cut off date(i.e. 30.06.2015). In that, the fact that the petitioner had submitted application on 30.06.2015 has not been disputed. For that reason, respondent No.1 and other statutory Authorities will be obliged to decide the application preferred by the petitioner and take a final decision thereon expeditiously and not later than 3<sup>rd</sup> March, 2016. If any other application has been received from the districts which were otherwise excluded in terms of the impugned notification, within specified time, even those applications be processed by the respondent No.1 and other statutory Authorities in accordance with law before 3<sup>rd</sup> March, 2016 and decision thereon be communicated to the concerned applicants. If the decision is adverse to the concerned applicants, they will be free to challenge the same on grounds as may be permissible in law...'.

In view of the above directions of the Hon'ble High Court, WRC in its 241st meeting held on February 4-6, 2016 directed the RD / WRO to take action on each such application received.

AND WHEREAS, the institution filed W.P. No.(C) 6102/2015 & C.M. No.11095/2015 before the Hon'ble High Court of Delhi at New Delhi and the Hon'ble High Court had passed an order dated 02.02.2016 in which it has been directed that, '... The application filed by the petitioners will be decided by the respondents and a final decision will be taken thereon expeditiously, but not later than 3<sup>rd</sup> March 2016. If a decision is adverse to the petitioners, they will be free to file appropriate proceedings in accordance with law."

AND WHEREAS, NCTE hars has filed SLP in the Hon'ble Supreme Court against the order of the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble Supreme Court has directed to process the case but no order shall be passed thereon. The matter is next listed for hearing on 26.04.2016.

AND WHEREAS, the matter was placed before WRC in its 246<sup>th</sup> meeting held on March 16-18, 2016 and the Committee decided that "...The institution has applied for a B.Ed. course (APP2748) and a D.El.Ed. course (APP2763). This case relates to the D.El.Ed. course. An examination of the file shows that the institution has not submitted the NOC from the affiliating body. It has also not submitted the notarized copies of the revised building plan. The institution has not submitted the notarized copy of the Building Completion Certificate and the Non-Encumbrance Certificate. **Hence, Show Cause Notice be issued on the above grounds.** It is further clarified that the applications for the B.Ed. course (APP2748) and the D.El.Ed. course (APP2763) will be considered jointly to fulfill the requirement that the institution should be a composite one. Further, a copy of the application be sent to the State Government for its recommendation."

Besides this, you are also hereby directed to re-submit the processing fee of Rs.1,50,000/-. DD No.761287 dated 29.05.2015 for Rs.1,50,000/-. The DD submitted by you is sent herewith for revalidation.

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14(3)(b) of NCTE Act, 1993 on the above points giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
