SHOW CAUSE NOTICE(U/S 17)

WHEREAS, recognition was granted to the institution, namely, **MANSAROVAR COLLEGE, MANSAROVAR CAMPUS, BEHIND HARSIDDHI HOSPITAL, KOLAR ROAD, BHOPAL-462016, MADHYA PRADESH** under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated **07.07.2004 & 07.04.2005.**

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on **17.01.2015** and the reply was received on **05.02.2015.**

AND WHEREAS, Revised Recognition order was issued to the institution on **31.05.2015.**

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on **21.11.2014.**

AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on **06.05.2015** and the reply of Deficiency Letter was received in NCTE HQRs. on **04.06.2015 & 08.06.2015.**

AND WHEREAS, the VTR/letter was received from NCTE Hqrs. in WRO on **12.11.2015.**

AND WHEREAS, the matter was placed in **237th Meeting held on December 21-22, 2015** of WRC and the Committee decided that "...The reply of the institution in response to the NCTE hqrs letter was examined in the context of the inspection report of the NCTE hqrs conducted under section 13 of the NCTE Act, 1993. The following lacunae are seen from the reply of the institution:-

- (i) With respect to the maintenance of Endowment and Reserve fund, the institution has renewed the FDRs for D.Ed. course but the FDRs for B.Ed. and M.Ed. courses have still not been renewed;
- (ii) The institution has informed that it has organized practice teaching in seven Government schools. By way of proof, the letter from the District Education Officer, Bhopal has been attached;
- (iii) As regards, 'low attendance', the institution has attached the photocopies of attendance registers which shows 85% of attendance;



- (iv) As regards 'enriching the library', the institution has sent the photocopies of the stock registers, showing the new books added to the library i.e. 30 books; and
- (v) As regards the 14 students did not take the final examination, the institution has informed that 99 students have obtained counseling and that 94 students took the exam, only 05 students did not take the exam.

Hence, Show Cause Notice be issued on the point No.(i)".


Now therefore, this Show Cause Notice is issued u/s 17 f the NCTE Act, 1993. Your written representation should reach this office within 30 days from the date of this Notice. In case no representation is received within the stipulated time, it will be presumed that you have nothing to offer and in that event the WRC shall taken action for withdrawal of recognition u/s 17 of the NCTE Act, 1993.
