**SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, SIVA SHIKSHA PRASAR SAMITI, PLOT NO 449, STREET/ROAD/VILLAGE/TOWN/CITY - JAIDA, POST OFFICE/TEHSIL/TALUKA/DISTRICT - SHEOPUR, PIN CODE - 476337, MADHYA PREDESH had submitted the application on 25.06.2015 to the Western Regional Committee of the NCTE for grant of permission for increase in intake in D.El.Ed. Course of 2 years duration with an additional intake of 50 students.

AND WHEREAS, application of the institution was received without application ID. The institution vide email dated 16.02.2016 (received on 19.02.2016) has provided the application code No APP15688.

AND WHEREAS, the matter was placed before the WRC in its 247<sup>th</sup> WRC meeting held on April 4-6, 2016 and the Committee observed that "...An examination of the file shows the following deficiencies.

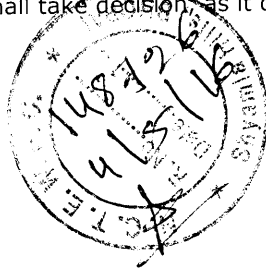
- i) Originally certified copy of land documents not submitted;
- ii) Notarized copy of CLU, not submitted and diverted area is only 2610 sq. mtrs which is less than the requirement;
- iii) Notarized copy of building plan, Building Completion Certificate, and Non-Encumbrance Certificate not submitted;

**Hence, Show Cause Notice be issued on the above grounds. Letter to the State Govt. for seeking its recommendation be sent under clause 7(4)."**

Besides this, you are also hereby directed to re-submit the processing fee of Rs. 1,50,000/- DD No. 002567 dated 03.10.2015 for Rs. 1,50,000/- . The DD submitted by you is sent herewith of revalidation.

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
