SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, KATNI ARTS AND COMMERCE COLLEGE, PLOT/KHASRA NO- 480/2 239/2, VILLAGE- KATNI, POST OFFICE- KATNI, TEHSIL- KATNI, DISTRICT- KATNI- 483501, CITY- KATNI, MADHYA PRADESH had submitted the application on 30.05.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration with an intake of 02 units of 100 students.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 gave its recommendation.

AND WHEREAS, the matter was placed before the WRC in its 235th Meeting held on November 23-24, 2016 and the Committee observed that "...The College applied online on 30.05.2015. However, the hard copy was received on 25.06.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS, the Rejection Letter was issued on 03.12.2015 to the institution.

AND WHEREAS, the Complaint Letters were received from Advocate S.P.Singh, High Court, Jabalpur on 05.12.2015, 09.03.2016, 15.03.2016 & 01.04.2016.

AND WHEREAS, the Appeal order dated 18.04.2016 was received on 26.04.2016 remanding the case to WRC.

AND WHEREAS, the matter was placed before the WRC in its 253rd Meeting held on May 24-26, 2016 and the Committee observed that "...This is a case of Appeal. An examination of the file shows that the institution has not submitted notarized copy of Society Registration Certificate and Bye-Laws, Building plan, Building Completion Certificate, CLU, Non-Encumbrance Certificate. The Society has not submitted any proof that it is running Liberal Arts and Commerce courses.

Hence, Show Cause Notice be issued on the above grounds."

Further, a complaint dt. 27/02/2016 was received in the WRO regarding the ownership of land. The institution be asked to submit its para-wise reply on the points raised in the complaint."
