SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, PREM NARYAN SHIKSHA PRASAR EVAM PARYAVARAN SAMITI, PLOT NUMBER - 283, STREET/ROAD - RAMEST VIHAR SHEETAL NAGAR, VILLAGE/TOWN/CITY/TEHSIL/TALUKA - DATIA, DISTRICT - DATIA, PIN CODE - 475661, MADHYA PRADESH had submitted the application on 28.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

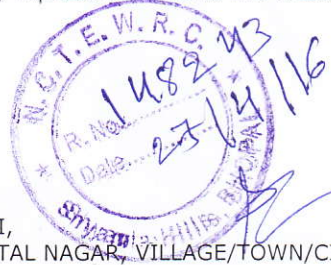
AND WHEREAS, the matter was placed before WRC in its 234th meeting held on November 3-4, 2015 and the Committee decided that "...As per public notice dated 27.02.2015 applications were not invited for D.El.Ed. course from Madhya Pradesh except from 20 districts which were listed in the notification. The WRO presented a list of 30 applications submitted for the D.El.Ed. course in agenda no 13 which are from the districts from where applications were not to be accepted. The WRC, therefore, decided to return the applications to these institutions alongwith processing fee. Copies of the letters be sent to NCTE Hqrs for refund of fees." Accordingly, application was returned on 12.11.2015.

AND WHEREAS, the institution filed W.P. No. 1002/2016 before the Hon'ble High Court of Madhya Pradesh, Bench at Gwalior and the Hon'ble High Court had passed an order dated 11.02.2016.

AND WHEREAS, the institution resubmitted the application to WRO on 17.02.2016 for reconsideration.

AND WHEREAS, the matter was placed before the WRC in its 247th WRC meeting held on April 4-6, 2016 and the Committee observed that "...On examination of the file, it is seen that the NOC from the affiliating body has not been submitted. Originally certified copy of the land documents, notarized copy of CLU/ Diversion order, Building Plan, Building Completion Certificate, and Non-Encumbrance Certificate not submitted. Diverted area is only 0.280 hectares, which is not sufficient. FDRs also not submitted. **Hence, Show Cause Notice be issued on the above grounds. Letter to the State Govt. be sent seeking its recommendation as per clause 7(4) of the NCTE Regulations, 2014.**"

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.




