SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act 1993, JAGRITI COLLEGE OF EDUCATION, PLOT/KHASRA NO- 32/1/2, 32/3/K/2, 32/3/KH/2, 3, STREET- BAHURI BANDH, VILLAGE- BAHURI BANDH, POST OFFICE- BAHURI BANDH, TEHSIL- HUZUR, CITY- REWA, DISTRICT: REWA- 486446, MADHYA PRADESH had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.


AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, SCN has been sent to the institution on 16.02.2016 at office level as per decision of WRC taken in 241st Meeting and the reply not received till the date.

AND WHEREAS, the matter was placed before the WRC in its 249th Meeting held on April 21-23, 2016 and the Committee observed that "...VT was constituted and the VT visited the institution on 14/04/2016. However, the inspection could not be conducted as there was no response from the management. Further, the VT found that there was no building or any construction in the specified Khasra numbers. A Panchnama to this effect was submitted to the WRO.

Hence, Show Cause Notice be issued on the above ground."

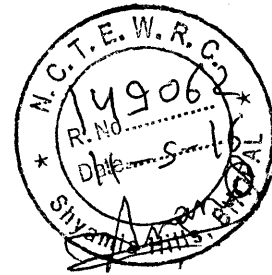
