SHOW CAUSE NOTICE

Whereas, recognition was granted to the institution namely, GWALIOR COLLEGE OF EDUCATION KALA SAYAD ROAD, TARAGANJ, GWALIOR MADHYA PRADESH under section 14(3)(a) of NCTE Act, 1993 for conducting D.ED course of two years duration with an annual intake of 50 students from session 2006-2007 vide order no. WRC/APW02676/222167 dated 27.09.2006.

And whereas, institution had applied for shifting of premises vide application dt. 06.03.2012.

And whereas, the matter was placed before the WRC in its 167th meeting held on 24-26, 2012 and the committee decided as follows "...LOI was issued to the institution on 27.4.2012. Vide their reply dt. 22.6.2012 the institution has submitted land documents, affidavit, CLU as required. Hence VT be constituted."

And whereas, the inspection of the institution was conducted on 26.08.2012.

And whereas, the matter was placed before the WRC in its 171st meeting held on September 17-18, 2012 and the committee decided as follows "...This is a case of shifting of premises. The VT was perused and the CD was viewed. The CD shows a good building and adequate infrastructure. Hence Shifting of premises is permitted." Shifting order was issued on 01.10.2012. the institution.

And whereas, The complaint received from Madhyamik Shiksha Mandal, Bhopal against the Colleges located in Gwalior which was considered by the WRC in its 229th meeting held on July 21-22, 2015. The Committee had decided that "the complaint be put up with recognition status of 39 institutions mentioned in the letter for consideration."

And whereas, matter was again considered by the WRC in its 231st meeting held on August 25-26, 2015. The Committee decided that " the institutions figuring in the list provided by the Madhyamik Shiksha Mandal be verified from the records whether the inspection of the institutions was carried out by the Collector, Gwalior earlier and after verification, detailed note be submitted for consideration."

And whereas, Collector, Gwalior vide letters dated 23/11/2015 and 16/12/2016 forwarded the reports of inspection to the office of Lokaayukt, M.P. which were forwarded to Madhyamik Shiksha Mandal vide their letter dt. 15/03/2016. Madhyamik Shiksha Mandal forwarded the copy of reports to the WRC for action against the institutions.

And whereas, the matter was placed before the WRC in its 253rd meeting held on May 24-26, 2016 and the Committee decided to issue Show Cause Notice to the institution on the following grounds:- "As per report the staff was not found available at the time of inspection. **Hence, Show Cause Notice under section 17 be issued to the institution on the ground that no activity was being conducted at the time of inspection. Neither students nor staff was available. Further, the institution should submit the latest approved list of the staff.**"

Now therefore, this Show Cause Notice is issued to the institution u/s 17 of the NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
