## SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, Chandrashekhar Shiksha Mahavidyalaya, Village: Bagha, Street/Road: Kothi Road, Taluka/ Mandal: Raghuraj Nagar, Town/City: Satna, District: Satna-485001, Madhya Pradesh had submitted the application on 04.07.2016 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed./B.Sc.B.Ed. Integrated course of 4 years duration.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 01.08.2016, 16.09.2016 & 16.10.2016 requesting to give their recommendation/comments.

AND WHEREAS, the Visiting Team visited the institution on 24.01.2017.

AND WHEREAS, the visiting team report alongwith other document, were placed before WRC in 270<sup>th</sup> meeting held from March 1-3, 2017 the committee observed that:-

"...The VT visited the institution on 24/01/2017. The CD was seen and VTR perused and the observation of the VT is "...When VT members reached to inspect the institution on dated 24.1.2017, the building of B.A.B.Ed./B.Sc.B.Ed. could not be seen. As per the management statement the building is under construction and it is not in a position to inspect. The management also stated that it has not submitted the building completion certificate to WRC NCTE for the same.

**Hence, Show Cause Notice be issued to the institution as to why the Recognition should not be refused on the above grounds.**

**Reply should be submitted within 30 days."**

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15 (3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
