

SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, Spriha Shiksha Evam Kalyan Samiti, Plot no.: 17/7, Vill.: Palari, P.O.: Seoni, Teh./Tal.: Seoni, Town/City: Seoni, Dist.: Seoni - 480661 Madhya Pradesh had submitted the application on 24.09.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.A.B.Ed./B.Sc.B.Ed. Integrated course of 4 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 13.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 19.11.2015 has given the recommendation.

AND WHEREAS, in 241th meeting of the WRC held on February 04-06, 2016 it was decided as under:

"...The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

Hence, in view of the above, Show Cause Notice is issued on the following points:-

1. Photo copy of Approved building plan submitted. Approved by Sarpanch Gram Panchayat Palari, Seoni. of Khasara no. 17/7, total land area 4049 sqr.mtr & built-up area 2960 sqr.mtr. Built up area is less. Blue print/Notarized copy of approved building plan issued by the competent authority not submitted. Built up area is less.
2. Change of land use certificate issued by the competent authority not submitted. (It should be notarized.)
3. Non encumbrance certificate submitted but notarized copy not submitted.
4. Notarized copy of Building Completion certificate issued by Govt. Engineer (RES) not submitted.
5. FDR of Rs. Five lakhs in original from Nationalized Banks towards Endowment Fund not submitted.
6. FDR of Rs. Seven lakhs in original from Nationalized Banks towards Reserve Fund not submitted.
7. As per online application Name of Institution and Name of Society are same.
8. The name of the course in the online application is B.A.B.Sc. As per norms the name of the course is B.A.B.Ed./B.Sc.B.Ed. Hence, Clarification would need to be given by the institution that for which course it has applied for i.e. B.A.B.Ed. or B.Sc. B.Ed.
