SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, PANDIT SHYAMACHARAN UPADHYAY SHIKSHA AVAM SAMAJ KALYAN SAMITI, PLOT NO.1693, 139, STREET/ROAD - JORA ROAD, VILLAGE/POST OFFICE/TEHSIL/TALUKA/TOWN/CITY/DISTRICT - MORENA, PIN CODE - 476001, MADHYA PRADESH had submitted the application on 30.09.2011 to the Western Regional Committee of the NCTE for grant of recognition for an annual intake of 50 students in D.El.Ed Course of 2 year duration.

AND WHEREAS, the deficiency letter was issued to the institution on 31.12.2011.

AND WHEREAS, the matter was placed before WRC in its 162nd meeting held on May 10, 2012 and the Committee decided that Rejection letter be issued to the institution. Accordingly, Rejection letter was issued on 05.06.2012.

AND WHEREAS, the institution filed W.P. No.2012/2015 before the Hon'ble High Court of Madhya Pradesh, Bench at Gwalior and the Hon'ble High Court had passed an order dated 16.12.2015.

AND WHEREAS, the aforesaid court order was placed before WRC in its 240th WRC meeting held on January 20-22, 2016 and the Committee observed that "...This case is being considered as directed by the Hon'ble High Court of Madhya Pradesh in their Order dt. 16/12/2015 in W.P.No.2012/2015.

The documents submitted by the applicant were examined. The following lacunae are seen:-

- Notarized copy of CLU not submitted;
- Diverted area and built up area are less than as required for existing B.Ed. and proposed D.El.Ed. course;
- Notarized copy of the Building Plan not submitted;
- Notarized copy of Building Completion Certificate not submitted;
- Notarized copy of Non-Encumbrance Certificate not submitted; and
- FDRs not submitted.

Hence, Show Cause Notice be issued on the above grounds".

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 15(3)(b) of NCTE Act, 1993 giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and Western Regional Committee shall take the decision, as it deems fit and proper.
