**SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **MANGALAM SOCAIL WELFARE SOCIETY, PLOT NO.39/1, STREET/ROAD – MAIN ROAD, VILLAGE/POST OFFICE – RASEELPUR, TEHSIL/TALUKA – HATA, TOWN/CITY – RASEELPUR, DISTRICT – DAMOH, PIN CODE – 470775, MADHYA PRADESH** had submitted the application on 28.06.2015 to the Western Regional Committee of the NCTE for grant of recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 students.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 29.10.2015, 17.12.2015, and 08.01.2016 requesting to give their recommendation/comments.

AND WHEREAS, Rajya Shiksha Kendra, Bhopal, Madhya Pradesh vide letter dated 19.01.2016 has given their recommendation.

AND WHEREAS, application was scrutinized and following deficiencies/shortcomings have been observed:-

- Originally certified copy of land documents not submitted, only photocopy submitted.
- Blue print/Notarized copy of Building plan not submitted, Only Photocopy Submitted.
- Notarized Copy of Building Completion Certificate not submitted.
- No Objection Certificate from the affiliating body not submitted by the institution.
- Notarized copy of non-encumbrance certificate not submitted.
- FDRs not submitted as per NCTE Regulations, 2014

AND WHEREAS, in the 241<sup>st</sup> meeting of WRC held on February 4-6, 2016, it was decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be.

NOW THEREFORE, this Show Cause Notice is issued to the institution u/s 14/15(3)(b) of NCTE Act, 1993 on the above points giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that the institution does not wish to make any representation and the Western Regional Committee shall take decision, as it deems fit and proper.
