Show Cause Notice

Whereas, in terms of section 14 of the NCTE Act, Shri Rawatpura Sarkar Lok kalyan Trust, Shri Rawatpura Sarkar Ashram, Vill- Dhaneli, Post- Mana, Tehsil- Dharsiva, District- Raipur-495001, Chhattisgarh. had submitted the application on 30.06.2015 to the Western Regional Committee, of the NCTE, for grant of recognition/permission for starting the B.A./B.Sc.B.Ed. course of 04 years duration.


In 241st meeting of the WRC held on 04th -6th February, 2016, it was decided that WRO should process the case and constitute VT issue SCN, as the case may be.

And whereas, scrutiny of the application shows the following lacunae:-

- (i) **No Objection Certificate from the affiliating body as per clause 5(3) of NCTE Regulation, 2014 not submitted;**
- (i) **Certified copy of registered land documents issued by the competent authority as required under provision of section 8(7)(i) of NCTE, Regulations, 2014 not submitted.**
- (ii) **A notarized copy of Change of land use (CLU) certificate as per Govt. format Not Submitted.**
- (iii) **Building Completion Certificate not submitted.**
- (iv) **Non encumbrance certificate not submitted.**
- (v) **FDR as per NCTE Regulation, 2014 Not Submitted.**
- (vi) **A copy of approved Building Plan having demarcated land area and built up area for applied D.El.Ed. and B.A./B.Sc. B.Ed. Course, proposed teacher training course being conducted by Institute not submitted.**

Now therefore, this show cause notice is issued to the institution giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.
