**Show Cause Notice**

Whereas, in terms of section 14 of the NCTE Act, Shri Rawatpura Sarkar Lok Kalyan Trust, Shri Rawatpura Sarkar Ashram, Village- Dhaneli, Post- Mana, Tehsil- Dharsiva, District- Raipur, Chhattisgarh had submitted the application on 30.06.2015 to the Western Regional Committee, of the NCTE, for grant of recognition/permission for starting the D.El.Ed. (Face to Face) course of 02 years duration.

In 241<sup>st</sup> meeting of the WRC held on 04<sup>th</sup> -6<sup>th</sup>, February, 2016, it was decided that WRO should process the case and constitute VT issue SCN, as the case may be.

And whereas, scrutiny of the application shows the following lacunae:-

- (i) **NOC from affiliating body as per clause 5 (3) of NCTE Regulation 2014 not Submitted.**
- (ii) **A copy of approved Building Plan having demarcated land area and built up area for applied B.A. B.Sc. B.Ed. (4 years) Integrated Course, proposed D.El.Ed. course is not submitted.**
- (iii) **Building Completion Certificate not submitted.**
- (iv) **Non-Encumbrance Certificate not submitted.**
- (v) **FDRs as per NCTE Regulations, 2014 not submitted.**

Now therefore, this show cause notice is issued to the institution giving an opportunity for making a written representation within a period of 30 days from the date of issue of this notice. In the event this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.

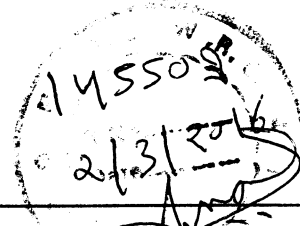
