WITHDRAWAL ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to **Govindrao Pawar College of Physical Education, Kalamb, Yavatmal, Maharashtra** vide order No. **WRC/5-6/96/5400-5401** dated **14.10.1998** For conducting the **B.P.Ed.** course with an annual intake of **60** seats.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 **Govindrao Pawar College of Physical Education, Kalamb, Yavatmal, Maharashtra** offering **B.P.Ed.** course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. **09.01.2015** from the institution, a revised recognition order no **WRC/OAPW0237/114072/2015/147496-503** dt. **31.05.2015** was issued to the institution for conducting **B.P.Ed.** Programme of two years duration with an annual intake of 100 seats (one basic unit of 100 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014:-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22-24, 2016 and Committee decided to issue Show Cause Notice dt. 02.01.2017.

And whereas, reply of show cause notice was submitted on 20.12.2016 by the institution and the matter placed before the WRC in its 292nd meeting held on May 15-17, 2018 and the Committee decided as follows :-

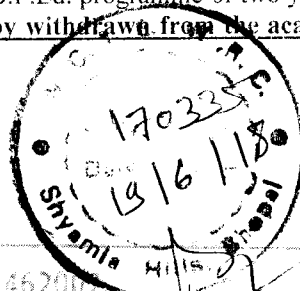
"...The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 11.11.2016 was issued.

The institution vide reply dated 15.12.2016 has submitted the staff profile of five faculty members, which is not as per Appendix-VII of NCTE Regulations, 2014. Principal has not been appointed.

FDRs for Rs.12.00 lakhs in joint account and Building Completion Certificate issued by a Government Engineer not submitted in original.

Hence, Recognition is withdrawn from the next academic session 2018-2019."

Now, therefore, the recognition of **Govindrao Pawar College of Physical Education, Kalamb, Yavatmal, Maharashtra** for conducting B.P.Ed. programme of two years duration with an annual intake of 100 seats (one basic units of 100 students), is hereby withdrawn from the academic session 2018-2019 in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
