REFUSAL ORDER

WHEREAS in terms of section 15 of the NCTE Act, 1993, **AMBHIKESH CHILDREN EDUCATIONAL AND WELFARE SOCIETY, VILLAGE : LALGAON, STREET/ROAD : BAUDRA, TALUKA/MANDAL : SIRMOUR, TOWN/CITY : REWA, DISTRICT: REWA - 486117, MADHYA PRADESH** had submitted the application on **10.05.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **REWANCHAL EDUCATION COLLEGE, KHASRA NO. : 11/415, STREET/ROAD :(TILAK NAGAR) INDIRA NAGAR REWA, TALUKA/MANDAL : HUZUR, TOWN/CITY : 11/415, DISTRICT: REWA - 486001, MADHYA PRADESH** for conducting the **B.A.B.Ed./B.Sc.B.Ed. 4 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 31.05.2016 requesting to give their recommendation/comments.

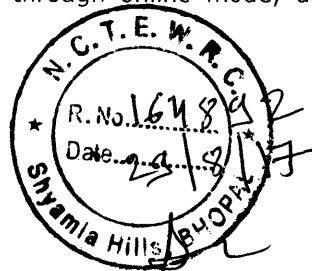
AND WHEREAS, the matter was placed before the WRC in its 266th meeting held on January 10-12, 2017 and the Committee decided that "... A perusal of the documents shows that the institution does not have a valid land as per clause 8(4)(i) of the NCTE Regulations, 2014. It has also not submitted valid CLU as on date. **Hence, Show Cause Notice be issued to the institution on the above grounds. Reply should be submitted within 30 days.**"

AND WHEREAS, the Show Cause Notice was issued on 17.01.2017 through online.

AND WHEREAS, the matter of reply not received was placed before WRC in its 278th meeting held on July 25-26, 2017. The Committee decided that "...The institute was informed through a show cause notice on 17.01.2017 that it does not have a valid land and CLU. The institute has not replied till date. **Hence, Recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to **REWANCHAL EDUCATION COLLEGE, KHASRA NO. : 11/415, STREET/ROAD : (TILAK NAGAR) INDIRA NAGAR REWA, TALUKA/MANDAL : HUZUR, TOWN/CITY : 11/415, DISTRICT: REWA - 486001, MADHYA PRADESH** for the **B.A.B.Ed./B.Sc.B.Ed. 4 - Years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
