**REFUSAL ORDER**

WHEREAS in terms of section 14 of the NCTE Act, 1993, **JAN SEVA SHIKSHA SAMITI, VILLAGE: PRITHVIPUR, STREET/ROAD: PRITHVIPUR, TALUKA/ MANDAL +TOWN/CITY: PRITHVIPUR, DISTRICT: TIKAMGARH-472336, MADHYA PRADESH** had submitted the application on **30.05.2016** to the Western Regional Committee of the NCTE for grant of recognition/permission to **JAN SEVA SHIKSHA MAHAVIDHYALAY, SURVEY NO. 365, 366/2, 513/1, VILLAGE: PRITHVIPUR, STREET/ROAD: PRITHVIPUR, TALUKA/ MANDAL +TOWN/CITY: PRITHVIPUR, DISTRICT: TIKAMGARH-472336, MADHYA PRADESH** for conducting the **D.P.S.E. 2 Years** programme.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 10.06.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 266<sup>th</sup> meeting held on January 10-12, 2017 and the Committee decided that "....A perusal of the documents shows that this course is proposed in a standalone institution.

Further, some of the documents submitted by the institution have been submitted to the SDM, Prithvipur, Dist. Tikamgarh for verification by the issuing authority. Reply is awaited.

**Since, it is a standalone institution, Show Cause Notice be issued to the institution as to why its recognition should not be refused.**

**Reply should be submitted within 30 days."**

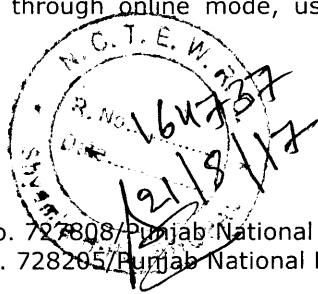
AND WHEREAS, the Show Cause Notice was issued on 17.01.2017 through online.

AND WHEREAS, the matter of reply not received was placed before WRC in its 278<sup>th</sup> meeting held on July 25-26, 2017. The Committee decided that "....The institute was informed through a show cause notice on 17.01.2017 that it is a stand alone institution further it has not submitted Non - encumbrance certificate and land use certificate. The building plan submitted is not of this College. The institute has not replied till date. **Hence, Recognition is refused. FDRs, if any, be returned."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **JAN SEVA SHIKSHA MAHAVIDHYALAY, SURVEY NO. 365, 366/2, 513/1, VILLAGE: PRITHVIPUR, STREET/ROAD: PRITHVIPUR, TALUKA/ MANDAL +TOWN/CITY: PRITHVIPUR, DISTRICT: TIKAMGARH-472336, MADHYA PRADESH** for the **D.P.S.E. 2 - Years** programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website [www.ncte-india.org](http://www.ncte-india.org).
