REFUSAL ORDER

WHEREAS, in terms of Section 15 of the NCTE Act, NUTAN SHIKSHAN SAMITI, 25 PANCHWATI JANAKI NAGAR, TEHSIL - INDORE, DISTRICT - INDORE, MADHYA PRADESH (WRCAPP201660200/9424/222) had submitted on 29.06.2016 the application to the Western Regional Committee of the NCTE for grant of recognition to, TAGORE SHIKSHA MAHAVIDYALAYA, VILLAGE - JAMBUDI HAPSI, STREET/ROAD - ARIHANT NAGAR, TALUKA/MANDAL - INDORE, TOWN/CITY - JAMBUDI HAPSI, DISTRICT - INDORE, PIN CODE - 452113, MADHYA PRADESH for starting the D.El.Ed. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 29.07.2016, 13.09.2016, and 13.10.2016 requesting to give their recommendation/ comments.

AND WHEREAS, the matter was placed in 266th WRC meeting held on January 10-12, 2017 and the Committee decided that "...An examination of the file shows that the institution has applied for increase in intake of the D.El.Ed. course from 2 units to 3 units. However, the NCTE Hqrs. vide letter dated 08.12.2016 has clarified that, "...the institutions may apply for increase in intake in the same course already recognized provided it does not exceed maximum of two permissible units in case of DPSE, D.El.Ed. and B.Ed. Any application for increase in intake beyond two permissible units in these three courses is not permissible under the regulation..." **Therefore, Recognition for additional unit is refused.**"

AND WHEREAS, the matter was placed in 267th WRC meeting held on January 23-25, 2017 and the Committee decided that "...Serial No. 37 (Code- APP201660200) - The last line should be read as "Show Cause Notice be issued on the above grounds." Accordingly, Show Cause Notice was issued on 01.02.2017

AND WHEREAS, the reply received from the institution was placed in the 279th Meeting of WRC held on August 10-11, 2017 and the Committee decided that "Show cause notice was issued regarding the non-permissibility of institution running more than two units of the D.El.Ed course. Since there has not been any valid reply, **Recognition for additional intake is refused.**"

NOW, THEREFORE, the WRC, in exercise of powers vested u/s 15 (3)(b) of the NCTE Act, hereby refuses recognition to TAGORE SHIKSHA MAHAVIDYALAYA, KHASRA NO -576/2, VILLAGE - JAMBUDI HAPSI, STREET/ROAD - ARIHANT NAGAR, TOWN/CITY - JAMBUDI HAPSI, TALUKA/MANDAL/DISTRICT - INDORE, PIN CODE - 452113, MADHYA PRADESH for the D.El.Ed. Course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. 
