REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, GOVERNMENT UNIVERSITY, PLOT NO: HOUSE NO- 02, STREET: NO: 123, VILLAGE- BHOJ UNIVERSITY CAMPUS, POST OFFICE: KOLAR ROAD, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462042, MADHYA PRADESH had submitted the online application on 28.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to ATAL BIHARI VAJPAYEE HINDI VISHVAVIDYALAYA, PLOT NO: HOUSE NO- 02, BLOCK NO: 04, STREET NO: 123, VILLAGE- BHOJ UNIVERSITY CAMPUS, POST OFFICE: KOLAR ROAD, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462016, MADHYA PRADESH for starting the B.Ed. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 01.10.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the VT has been constituted at office level as per decision of WRC taken in 236th Meeting. There is positive recommendation of the State Govt. for B.Ed. Course.

AND WHEREAS, the Regional Director, WRO constituted the visiting team.

AND WHEREAS, the inspection letter issued to the institution on 21.01.2016 and the inspection conducted of the institution on 28.01.2016.

AND WHEREAS, the reply was placed before the WRC in its 241st Meeting held on February 4-6, 2016, the committee observed that:- "...VT was constituted by the WRO. The VT went to inspect the premises on 28/01/2016. However, the applicant University refused to get the inspection done, and has informed vide its letter dt. 27/01/2016 that it will communicate the dates for inspection after full preparation by it.

The University be informed, that as per the orders of the Hon'ble Supreme Court (Order dt. 13/12/2012 passed in W.P. (civil) No. 276/2012 filed by Maa Vaisno Devi Mahila Mahavidyalaya Vs. State of U.P. and others), Recognition from a particular session can be given only if the Recognition order is passed by / before 3rd March of that year. Hence, if Recognition is desired from 2016-2017, the Recognition order will have to be issued by /before 3rd March, 2016.

The applicant also be informed that after VT inspection, the process of issue of Letter of Intent has to be undergone, and Recognition can be issued only if everything is found to be in order. So all action is to be taken timely.

Since, the applicant University has refused to get the inspection done, it should pay the inspection fee of Rs.1.50 lakhs for subsequent inspection."

AND WHEREAS, the Clarification letter was issued to the institution on 20.02.2016 and the reply has not been received.

AND WHEREAS, the matter was placed before the WRC in its 251st Meeting held on April 30-May 2, 2016, and the Committee observed that "...In the 241st meeting, the WRC had noted that the applicant University had refused to get the inspection done. It also informed vide letter dt. 27/01/2016 that it will communicate the dates for inspection after full preparation by it. Since, this is a State University; it is not required for them to pay the inspection fee of Rs. 1.50 lakhs. The University has still not intimated the WRC of its preparedness.

The VT will be constituted on receiving of this letter."

AND WHEREAS. the Clarification letter was issued to the institution on **06.05.2016** and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 266th Meeting held on January 10-12, 2017 and the Committee observed that "...Clarification letter/Show Cause Notice dt. 06/05/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

NOW, THEREFORE. the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **ATAL BIHARI VAJPAYEE HINDI VISHVAVIDYALAYA, PLOT NO: HOUSE NO- 02, BLOCK NO: 04, STREET NO: 123, VILLAGE- BHOJ UNIVERSITY CAMPUS, POST OFFICE: KOLAR ROAD, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462016, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
